## 1 CONFIRMATION OF MINUTES OF THE 16<sup>TH</sup> SOHNSS AGM

Minutes of the last AGM was passed with no amendments. Proposed by Dr Lynn Koh and seconded by Dr Lee Tee Sin.

## 2 SOHNSS ANNUAL ACTIVITIES REPORT 2022

Dr Valerie presented the activities report from January to December 2022, which includes

- Combined SOHNSS & Chapter of ORL CME Dinner Symposium on 04 July, Pan Pacific
- Annual Sports Day on 24 September, Turf City
- 4<sup>th</sup> SOHNSS & Chapter of ORL Annual Scientific Meeting (Facial Plastic Surgery) on 01
   October, Novotel on Stevens
- Social Event: 25hours Wine Appreciation Masterclass

SOHNSS had also supported 7 CME applications in 2022.

SOHNSS is now nation member of the followings societies:

- ASEAN Otorhinolaryngological Head & Neck Federation
- International Federation of ORL Societies
- International Federation of Head and Neck Oncologic Societies

As of 31 December 2022, there are 96 full members, 42 associate members and 2 life members.

This activity report was unanimously approved by the house. Proposed by Dr Charn Tze Choong and seconded by Dr Barrie Tan.

#### 3 SOHNSS ANNUAL FINANCIAL REPORT 2022

- 3.1 The audited financial report for year 2022 was presented by Hon. Treasurer, Dr Tze Choong, with a surplus of \$\$16,442.89.
- 3.2 Dr Tze Choong also reported the financial statement for ASEAN ORL Federation on behalf of Dr Song Tar, as the account is kept under the auspice of SOHNSS.
- 3.3 The financial reports were approved with no questions. Proposed by Dr Valerie Tay and seconded by Dr Soma Subramaniam.



#### 4 ANNUAL SCIENTIFIC MEETING 2022

4.1 Dr Valerie reported that a physical annual scientific meeting was held on 01 October 2022. The theme was Developments in Asian Facial Plastic and Reconstructive Surgery.

A total of 63 members attended the meeting and the finalised surplus of the event is \$17,477.

4.2 Meanwhile, she also informed that the next ASM will take place on 27 May 2023, at the Raffles City Convention Centre. Theme for this year's meeting is "Sleep: Not Always a Bed of Roses".

#### 5 FIXED DEPOSIT

- 5.1 At the last virtual AGM, the house suggested exploring SSB & T-bill as an alternative to fixed deposit due to the low interest rate.
- 5.2 Dr Valerie updated that the EXCO explored various investment channels. Unfortunately, the Singapore Saving Bonds are open to individual investors only. And due to compliance issues, the society is not allowed to proceed with other investment products as the society constitution did not indicate any conditions for investment.
- 5.3 Hence, the committee has decided to withdraw the principle and interest from the current fixed deposit account and deposit a fresh fund of \$200,000 into MayBank to lock the current interest rate of 3.0% for 24 months.
- 5.4 For future investment purpose, the committee proposed amending the constitution by including an investment clause. However, the house decided to keep the investment to fixed deposit only as the society is not aiming at generating profit.

Dr Valerie presented a certificate of appreciation to all outgoing EXCO members. A vote of thanks to the President was recorded.

## 10 ANY OTHER BUSINESS

Dr Valerie informed that the Singapore Tourism Board wrote in to the society, asking if SOHNSS would be interested in hosting the World Congress of the International Federation of Head and Neck Oncologic Societies. She highlighted that the next series will be 12 years down the road, it would be difficult to organise any concrete decision now. However, she has brought forward this to the Head & Neck fraternity for them to further discuss.

There being no other business, the meeting adjourned at 2000hrs.
